

Appliances Online x Samsung Birthday Competition 2024

Terms and Conditions

1. The competition commences at 10am (AEDT) on 16/09/2024 and concludes at 11.59pm (AEDT) on 30/09/2024 (**Competition Period**). Winners will be decided on 10/10/2024 at 11am at Appliances Online, Level 2, 20A Danks St, Redfern NSW.
2. Entries open to NSW, VIC, QLD, SA, WA, ACT and TAS residents only. Employees (and their immediate families) of Appliances Online are ineligible to enter.
